No. 25528/2018, Order dated 03.12.2018 passed by the Hon'ble Supreme Court in SLP(c) No. 30989/2018 and Order dated 16/01/2019 passed by the Hon'ble High Court of Judicature at Allahabad in Contempt Application (Civil) No. 5645/2018, the Council appointed assessors to carry out the compliance verification assessment and assessment of F.H. Medical College, Agra, U.P. for infrastructure for approval for the academic year 2019-2020 on 20th & 21st February, 2019. The said assessment reports(20th & 21st February, 2019) were considered by the Board of Governors and the Board of Governors has decided to permit the F.H. Medical College, Agra, U.P. to admit the students for admission of fresh batch of 150(one hundred fifty only) MBBS students u/s 10A of the IMC Act, 1956 for the academic Year 2019-2020.
